

**N.O.C. from sanitation point of view for proposed construction of residential building.**

With reference to your letter No.VP/V/60/2021-22 dated 09/04/2021, it is to inform you that this PHC CORTALIM has **NO OBJECTION** to issue NOC from the SANITARY POINT OF VIEW for proposed construction of residential building as per Technical Clearance from TCP vide No: TPM/32785/Verna/193/4/20-21/1298 dated 22/03/2021 in property bearing Sy. No. 193/4 of Verna Village of Salcete Taluka by **Mr. Amit C. Prabhu**, subject to the following conditions:

1. The construction shall be carried out as per the plan submitted.
2. The STP shall be more than **15** meters away from any water source and the capacity of the STP should correspond to the details as submitted to this office.
3. Consent to Establish from Goa Pollution Control Board shall be obtained within 3 months from the issue of NOC.
4. Proper cleanliness and sanitation should be maintained at the construction site.
5. No health hazard or any other environmental pollution shall be created in the surrounding area.
6. The owner/contractor shall co-operate with the Health and Pollution Control Authorities whenever they visit the site for inspection.
7. As per section 75 A of Goa Public Health Act all labourers shall possess valid health cards, renewable every three months from its date of issue. Whosoever contravenes the above provision shall be fined Rs.10000/- per labourer. Health cards should be available at the site for inspection.
8. All Sanitary facilities (Toilet/Soak pit for proper disposal of waste water, Mosquito nets) should be provided to the labourers at the construction site.
9. Adequate anti-larval measures shall be carried out at the construction site in consultation with the health authority.
10. The owner/contractor shall display the signboard at the site with details such as name of the Proprietor/Builder/Contractor, NOC details obtained from the various appropriate Authorities.
11. This office is not responsible for any court Litigation regarding the ownership and area of the property.
12. **The Employment of Manual Scavengers is prohibited under Act, 2013. No Manual scavenging shall be allowed.**
13. Two soak pits shall be constructed one for sewage and another for sullage waste of the building.
14. The N.O.C. is liable to be withdrawn if the conditions stipulated above are not complied with.
15. The Applicant should take necessary approval / permission for construction from the local authority and other government agencies before starting of construction.
