- 7. Roads, Open space and drains have to be developed as per the required standards for the purpose.
- 8. Open space should be handover to the office of Village Panchayat Batim before issuing of Final Sub Divisional NOC.
- 9. Adequate No. of trees must be planted to maintain Greenery in the area.
- 10. All roads will be treated as public roads.
- 11. Provision must be kept for Garbage and Waste management.
- 12. Conversion Sanad should be obtain before commencement of work.
- 13. Necessary permission may be obtained from any other competent authority/ Department if necessary as per the rules and regulations in force.
- 14. The Provisional sub- division Permission shall be revoked
 - a) If the Sub –division of plots is not executed as per the plans approved and statement therein.
 - b) Whenever there is any false statement or any misrepresentation of any material or documents passed approved or shown in the application on which the permit was passed.
- 15. The NOC is granted as per the NOC issued from Town and Country planning Department vide no. Ref. No. TIS/8163/GAN/TCP/2022/604 dated 07/04/2022 and the condition imposed from Sr. No. 1 to 38 to be strictly followed.
- 16. The proposed Provisional permission for Sub Division of land in survey No.32/1-A of Village Gancim is issued as per the Resolution No.5(2) adopted in the fortnightly meeting held on 18/04/2022 by the village Panchayat Batim.
