- 3) No construction should be carried out after issue of occupancy certificate
- 4) Trees should be planted within plot area by the occupant of the building /bungalow so as to keep colva village clean & green
- 5) Not to discharge the wate water into the existing draining /nallah /pond in the open ground which is unhygienic in the vicinity
- 6) All water drains /road should b e strictly maintained by the occupant of the building /Bungalow
- 7) The waste collection ,segregation & composting station along with sanitary wastw incinator needs to be functional on daily bass ,dry waste to be disposed through proper channel as per the guideline from Goa Soild Waste Management Corporation
