- Plots should be clearly demarcated with distinct boundary stones and the dimensions and the area of each plot should be clearly mentioned.
- Roads, Open space and drains have to be developed as per the required standards for the purpose.
- Open space should be handover to the office of Village Panchayat Batim after issuing of Final Sub Divisional NOC.
- 7. Adequate No. of trees must be planted to maintain Greenery in the area.
- 8. All roads will be treated as public roads.
- 9. Provision must be kept for Garbage and Waste management
- Necessary permission may be obtained from any other competent authority/ Department if necessary as per the rules and regulations in force.
- 11. The Final sub-division Permission shall be revoked
 - a) If the Sub –division of plots is not executed as per the plans approved and statement therein.
 - b) Whenever there is any false statement or any misrepresentation of any material or documents passed approved or shown in the application on which the permit was passed.
- The NOC is granted as per the NOC issued from Town and Country planning Department vide no. Ref. No. TIS/9412/GAN/TCP/2021/2071, dated 06/12/2021, and the condition imposed from Sr. No. 1 to 17 to be strictly followed.
- 13. The Final permission for Sub Division of land in survey No.57/1-A, of Village Gancim is issued as per the Resolution No 4(2) adopted in the fortnightly meeting held on 21/12/2021 by the Village Panchayat Batim.
