Mr. Vishram P Walavalkar, r/o Mapusa, Bardez - Goa has paid the aforesaid amount of Rs.4,42,000/- (Rupees Four Lakhs Forty Two Thousand only), vide receipt No. 04084; dt. 06/06/2019, Rs.74,000/- (Rupees Seventy Four Thousand only), vide receipt No. 64085; dt. 06/06/2019 and Rs.583/- (Rupees Five Hundred and Eighty Three only), vide receipt No. 04086; dt. 06/06/2019 as per Bye-Laws in force, for Renewing Original Licence No. 03 dated: 17/04/2013, which was valid upto 16/04/2016. Time limit for completion of the said work is extended upto 16/04/2020 with the same terms and conditions imposed under Original licence No. 03; dated: 27/10/2015, and on additional conditions mentioned below:-

Conditions: -

- 1) This Construction Licence granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the Construction Licence and the Licensee will not be entitled for any compensation in case of misrepresentation of facts / submissions made by the Licensee.
- 2) All the Conditions stipulated in the Original Construction Licence No. 03 dated: 17/04/2013, R.C.C Licence should be strictly followed.
- 3) The Licensee shall dispose off the construction and demolition debris generated during the construction or demolition activity at either of the two designated sites i.e. at (a) NH 17 Green Park to Karaswada Right hand side of existing Mapusa By pass or (b) NH 17 Green park to Guirim Junction toll Plaza, without harming the environment, with prior intimation to Shri Eduardo Pereira, Assistant Engineer, Sub Division-II, Mapusa Works Division VII, Panaji. PWD Goa (Contact No. 7767016257, E-mail: [ee7-pwd.goa@nic.in](mailto:ee7-pwd.goa@nic.in)) [ as per the Notification No. 5-I-PCE-PWD-EO/2018/181; dated 07/03/2018 issued by the Principal Chief Engineer, PWD, Altinho, Panaji - Goa] and the undertaking on an affidavit in this regards shall be submitted to this Council before commencement of work. After disposal of the construction and demolition debris at the said designated sites, the necessary Certificate to be obtained by the Licensee, which is to be produced before the Council / Licensing authority. If the above undertaking is breached or the Certificate is not produced, penalty shall be levied as well as permission granted will be withdrawn.
