

We do hereby solemnly declare, undertake and state as under:-

That M/s Anand Bose Constructions Pvt. Ltd. has a legal title to the plot bearing survey No. 88/1-B on the land on which the development of the project namely 'Anand Elite' is proposed.

hat the project land is free from all encumbrances.

That the time period within which the project shall be completed by M/s Anand Bose Constructions Pvt. Ltd. is 30/04/2025;
