- 8. That we the developers shall inform the authority regarding all changes that have occurred in the information furnished under sub - section (2) of section 4 of the act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- 9. That we the developers have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That we the developers shall not discriminate against any allottee at the time of allotment of any apartment, shop, row bunglow & independent bunglow, as the case may be.
