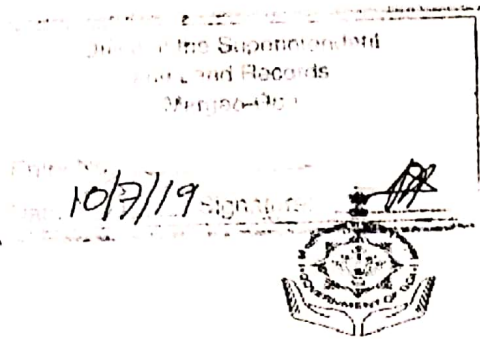

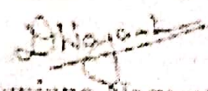
Sir,

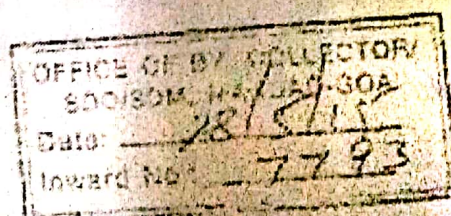
In view of the above the revised plan showing the correct position of survey No. 12/3-A & 12/3 is submitted herewith for further necessary orders in the matter.

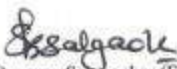


Plan Showing plot situated at

Scale : 1 : 1000

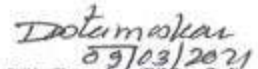
