- 1. The project has been registered under Gao RERA on 10<sup>th</sup> April 2019. The collections and withdrawals amounts are been considered from RERA registration date of the project.
- The collections of Rs. 48,22,611/- was received before RERA registration date & hence has not been considered in the current Form 6. However, if the collections received before 10<sup>th</sup> April 2019 were considered then the total collection received till 31<sup>st</sup> March 2020 would be Rs. 1,35,20,761/-.
- 3. The collection amounts have been extracted from the bank statement of the promoter's current a/c being the PNB Bank/ Oriental Bank of Commerce. The promoters do not maintain separate RERA A/c for the project.
