Whereas an application has been made to the Collector of North Goa (Hereinafter referred to as "the Collector" which expression shall include any officer whom the Collector shall appoint to exercise and perform his powers and duties under this grant) under section 32 of the Goa, Daman and Diu Land Revenue Code, 1968 (hereinafter referred to as 'the said code which expression shall, where the context so admits include the rules and orders thereunder) J. M. HOLDINGS PRIVATE LIMITED being the occupant of the plot registered under Survey No. 327/27-A situated at Mandrem Village, Pernem Taluka (hereinafter referred to as "the where applicants, which expression shall, the context so admits include his/her heirs, executors, administrators and assigns) for the permission to use the plots of land (hereinafter referred to as the "said plot" described in the Appendix I hereto, forming a part Survey No. 327/27-A admeasuring 2690 square meters be the same a little more or less for the purpose of Residential use with FAR 60%.

- 4. Liability for rates The applicants shall pay all taxes, rates and cesses leviable on the said land.

Penalty clause (a) if the applicant contravenes any of the foregoing conditions the Collector may, without prejudice to any other penalty to which the applicants may be liable under the provisions of the said Code continue the said plot in the occupation of the applicant on payment of such fine and assessment as he may direct.
  - (b) Notwithstanding anything contained in sub-clause (a) it shall be lawful for the Collector to direct the removal or alteration of any building or structure erected or use contrary to the provisions of this grant within such time as specified in that behalf by the Collector, and on such removal or alteration not being carried out and recover the cost of carrying out the same from the applicant as an arrears of land revenue.
- 6. a) The Information, if any, furnished by the applicant for obtaining the Sanad is found to be false at later stage, the Sanad issued shall be liable to be withdrawn without prejudice to the legal action that may be taken against the applicant.
  - b) If any dispute arises with respect to the ownership of the land, the Sanad granted shall stand revoked and the Construction/Development carried out shall be at the cost and risk of the applicants.
  - c) The necessary road widening set-back to be maintained before any development in the land.
  - d) Traditional access passing through the plot, if any, shall be maintained.
  - e) No trees shall be cut except with prior permission of the competent authority.
- 7. Code provisions applicable -Save as herein provided the grant shall be subject to the provisions of the said code and rules thereunder.
