## TECHNICAL CLEARANCE ORDER

Technical Clearance is hereby granted for proposed amalgamation of plots and construction of residential villas Type A, B, C & D (9 Nos.), swimming pools and compound wall as per the enclosed approved plans in the property Zoned as "Settlement Zone' in Regional Plan for Goa 2021 situated in Survey No.520/3 & 4 at Anjuna Village, Bardez- Goa, with the following conditions:-

- 1. Construction shall be strictly as per the approved plans. No change shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
- 2. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
- 3. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.
- 4. The Developer/applicant should display a sign board of minimum size 1.00 mts. X 0.50 mts. with writing in black color on a white background at the site, as required under the Regulations.
- 5. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the Commencement of any development/construction as per the permission granted by this order.
- 6. The Septic Tank soak pit should not be located, within a distance of 15.00 meters / as per the requirement of Health Act from any other existing well in the plot area/plan.
- 7. The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.
- 8. Completion Certificate has to be obtained from this Authority before applying for Occupancy Certificate from the licensing authority.
- 9. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
- 10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
- 11. In case of any cutting of sloppy land or filling of low-lying land, beyond permissible limits, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town & Country Planning Act, 1974.
- 12. The ownership of the property shall be verified by the licensing body before the issuing of the license.

- 13. The adequate arrangement for collection and disposal of solid waste generated within the complex shall be arranged to satisfaction of Village Panchayat.
- 14. Panchayat shall verify the infrastructural requirements such as water and power supply before issue of construction license.
- 15. Adequate storm water network shall be developed up to the satisfaction of Village Panchayat and same to be connected to the existing drain in the locality.
- 16. The area under road widening shall not be encroached/enclosed.
- 17. The said building should be used for residential purpose only as per the Technical Clearance Order.
- 18. Applicant shall plant one tree for every 100.00m2 of area developed, land scaping on open spaces/tree plantation along roads and in developed plots.
- 19. The Village Panchayat shall take cognizance of any issue in case of any Complaints court orders before issuing of construction license.
- 20. The height of the compound wall strictly maintained as per rules in force.
- 21. Gate of compound wall shall be open inwards only.
- 22. Applicant shall make his own arrangement of water requirements for swimming pool.
- 23. Applicant shall dispose the construction debris at his/her own level and/ or the same shall be taken to the designated site as per the disposal plan given by the applicant in the affidavit to be produced to the village Panchayat.
- 24. This Technical Clearance issued based on the Government approval vide Note no.TPB/5405/ANJ/TCP/ 20/249 dtd. 16/01//2020.



- 1. The permission is recommended as per the plans hereby annexed.
- 2. The Permission is liable to be revoked, if it is based on the false information/ Wrong Plans/calculations/documents or any other accompaniments of the applications are to be found to be incorrect or wrong at any stage.
- 3. Any change to be effected to the approved plans, prior permission has to be obtained.
- 4. Ownership of the land shall be verified by Village Panchayat before issue of Construction license.
- 5. Traditional access if any shall not be blocked, unless the plot or property so served is otherwise served by alternative access.
- 6. Verification of ownership of land with specific reference to tenancy as on 2/11/1990 has to be made at your end and before issue of construction license /Occupancy Certificate.
- 7. This Technical Clearance Order is issued as a partial modification to earlier Technical Clearance Order issued by this office vide letter no. TPB/5405/ANJ/TCP-20/946 dated 24/02/2020.
- 8. All conditions imposed in our earlier Technical Clearance Order issued vide no. TPB/5405/ANJ/TCP-20/946 dated 24/02/2020 shall be adhered strictly.
- 9. This Technical Clearance order is issued only for revision of STP to septic tank and soak pit only.
- 10. Applicant shall plant one tree for every 100.00 m2 of area developed, land scaping on open spaces/ tree plantation along roads and in developed plots.

- 11. Adequate avenue greenery should be developed.
- 12. The Village Panchayat shall take cognizance of any issue in case of any Complaints/court orders before issue of construction license.
- 13. Applicant shall dispose the construction debris at his/her own level and/ or the same shall be taken to the designated site as per the disposal plan given by the applicant in the affidavit to be produced to the village Panchayat.
