## **OPINION ON TITLE**

Sinforiano purchased the same in the judicial auction held by the Court in the execution proceedings filed by Fr. 10/12/1973 as a bachelor and Maria Amanda who was the fiduciary passed away subsequently on 8/2/1980.

Since the said Jose Aleixo who was the fedeicommisary passed away before the fiduciary Maria Amanda, all the estate of Fr. Sinforiano vested and descended and devolved on or to the said Maria Amanda.

The said Maria Amanda left behind a will dated 8/1/1980 executed before the Notary Public Ex-Officio cum Sub-Registrar of Mormugao at Vasco, appointing Francisco Xavier da Silva Moniz as her sole and universal heir.

Therefore, all the estate of Fr. Sinforiano which included all the properties he owned came to belonged to Francisco Xavier da Silva Moniz, as stated above.

one Fausto Dias, his wife, his brother Fr. In the form D of the above mentioned properties the name of Francisco Xavier da Silva Moniz has been registered as the occupant of the same.
