No. 208/5(part) & 6(part) situated at Arady, Candolim, Bardez Goa, in terms of Resolution No. 3 taken in the Panchayat meeting dated 16/10/2018 as per his/her application under inward No. 2611 dated 25/9/2018. The party who has been granted renewal construction licence shall comply with the following conditions.

- 1) To limit himself/herself to the plans approved and statements therein.
- 2) The construction shall be as per plans approved by this Panchayat and condition imposed on it.
- 3) To inform the Panchayat after excavation and before laying of plinth foundation.
- 4) To inform the Panchayat when the construction has been completed upto plinth level.
- 5) To inform the Panchayat as soon as the construction is completed.
- 6) Not to inhabit the building without the prior permission of this Panchayat.
- 7) To abide by the other related provision in force.
- 8) That building or construction is carried out as per the alignment given and the plinth level fixed by the Panchayat
- 9) The construction licence shall be revoked.
 - a) If the construction work is not executed as per the plans approved and statements therein.
 - b) Wherever there is any false statement or any misrepresentation of any material Passed, approved or shown in the application on which the permit was passed.
- 10) The points / conditions laid down in the original licence bearing No. VP/32/11/21/3009/2014-15 dated 21/02/2015 should be complied.

The licence shall be valid from 22/02/2018 to 21/02/2020. He/she had paid the respective tax/fees at the tune of Rs.1,93,500/- (Rupees One lakh ninety three thousand five hundred only) By Receipt No. 973/82 dated 27/10/18

CONSTRUCTION LICENCE



Amit Karwal P.O.A. holder from Mr. Avinash Karwal from Aradi, Bardez - Goa is hereby granted licence for the Construction of Residential blocks A, B & C, Swimming pool, part compound wall and amalgamation of plots in survey No. 208/5 (part) & 6 (part) situated at Aradi, Candolim, Bardez Goa, in terms of Resolution No. 7(3) taken in the Panchayat meeting dated 18/02/2015 as per the plans in triplicate/duplicate attached to his/her application under inward No. 2727 dated 27/12/2014. One copy of the plans concerned with the approval note carrying the embossed seal of this Panchayat and duly signed is returned to the interested party, who shall comply with the following conditions.

- 1) To limit himself/herself to the plans approved and statements therein.
- 2) The construction shall be as per plans approved by this Panchayat and condition imposed on it.
- 3) To inform the Panchayat after excavation and before laying of plinth foundation.
- 4) To inform the Panchayat when the construction has been completed upto plinth level.
- 5) To inform the Panchayat as soon as the construction is completed
- 6) Not to inhabit the building without the prior permission of this Panchayat.
- 7) To abide by the other related provision in force.
- 8) That building or construction is carried out as per the alignment given and the plinth level fixed by the Panchayat
- 9) The construction licence shall be revoked.
 - a) If the construction work is not executed as per the plans approved and statements therein.
 - b) Wherever there is any false statement or any misrepresentation of any material passed, approved or shown in the application on which the permit was passed.
- 10) That the area under the road widening should be maintained as shown on the plan.
- 11) That the Occupancy Certificate should be applied from this office, after completion of the said construction work.
- 12) That the conditions from Sr. No. 1 to 31 from the Dy. Town Planner, vide his letter No. TPBZ/61/CAN/TCP/14/3658 dated 13/11/2014 should be complied.
- 13) That the NOC for Sewage Treatment Plant should be obtained from the GSPCB, Panaji and the same should be produce to this office before commencement of work.
- 14) That the NOC from the Fire & Emergency Department, Panaji should be obtained and the same should be produce to this office before commencement of work.

The licence shall be valid for a period of three year beginning from today. He/she had paid the respective tax/fees the tune of Rs. 2,15,000/- (Rupees Two Lakh Fifteen Thousand only) By Receipt No. 716/100 dated 21/02/2015.
