Affidavit cum Declaration of Mr. Anil Amrutrao Bandodkar as a Proprietor of M/s Maharudra Realtors, as Promoter and Developer of the project named RUDRA ARISTO, duly authorized by the promoter of the proposed project, I, Shri. Anil A Bandodkar son of Amrutrao N. Bandodkar aged 52 Indian national duly authorized by the Promoter and Developer of the proposed project do hereby solemnly declare, undertake and state as under:

(1) That I have a legal title Report to the land on which the development of the project is proposed.

(2) That the project land is free from all encumbrances. OR That details of encumbrances including dues and litigation, details of any rights, title, interest or name of any party in or over such land, along with details.

(3) That the time period within which the project shall be completed by me as a proprietor from the date of registration of project; is 15/03/2027

(4) (a) For new projects: That seventy percent of the amounts realised by me as a proprietor of the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

(b) For ongoing project on the date of commencement of the Rules-

(i) That seventy percent of the amounts to be realised hereinafter by me as a proprietor for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

(ii) That entire amounts to be realised hereinafter by me as a proprietor for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.


(5) That the amounts from the separate account shall be withdrawn in accordance with section 4 (2) (1) (D) read with rule 5 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017.

(6) That I the proprietor shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been compliance with the proportion to the percentage of completion of the project.

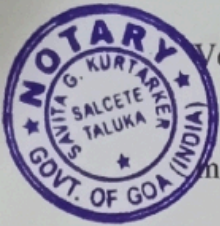
(7) That I the proprietor shall take all the pending approvals on time, from the competent authorities.

(8) That I the proprietor shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.

(9) That I the proprietor has furnished such other documents as have been prescribed by the rules and regulations made under the Act. (10) That I the proprietor shall not discriminate against any allottee at the time of any apartment, plot or building, as the case may be.
