1.This certification is not based on any on-site visits, as our technical qualifications do not permit us to directly assess the progress of work on-site. Instead, we rely on the Form 3 CA certified certificate dated 20th April 2024, which confirms the percentage of work completed on-site.

2.Furthermore, we have verified the ICICI Bank current accounts ending in 2053 and 2054 up to 31st March 2024 to confirm the amounts withdrawn from the designated account. However, we are unable to certify whether the amounts received daily from the allottees have been specifically utilized for the project. Therefore, the method followed for verification is to review the total amount received during the financial year 2023-24 from the project allottees, the total amounts deposited into the RERA designated account, and the total withdrawals made from the RERA designated account during the same period.
