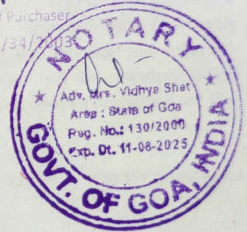



- (1) That promoter has a legal title Report to the land on which the development of the Project is proposed
- (2) That the project land is free from all encumbrances-
- (3) That the time period within which the project shall be completed by the promoter from the date of the registration of the project is **30/11/2026**
- (4) For new projects: That seventy percent of the amounts realized by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- (5) That the amounts from the separate account shall be withdrawn in accordance with section 4(2) (I) (D) read with rule 5 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosure on Website) Rules, 2017.
- (6) That promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- (7) That promoter shall take all the pending approvals on time, from the competent authorities.
- (8) That promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section(2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- (9) That promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- (10) That promoter shall not discriminate against any allottee at the time of allotment of any Apartment, plot or building, as the case maybe.


