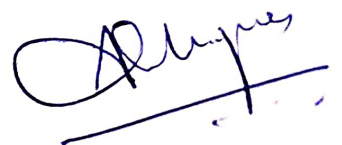
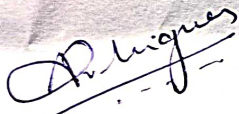

Note
