### SUBJECT TO THE FOLLOWING CONDITIONS:-

- (2) This certificate shall be treated as NOC for obtaining water and power connection.
- (3) The applicant should make independent provision for Garbage disposal within the plot Area by constructing Compost Pit and dispose the same properly in scientific manner.
- (4) The Premises should not be used for purpose other than mentioned in this certificate except with due permission of this Village Panchayat.
