Floor (Stilt Parking) + 7 Floors] Club House and Security Cabin in the property bearing Chalta No. 41 & 18 of P.T. Sheet No. 289 & 290 situated at Aquem Baixo, Margao-Goa.

- 9. Total period including renewal shall be permissible upto 3 years beyond which S.G.P.D.A. renewal shall be necessary.
- 10. Licencee shall abide by the conditions and regulation contained in the original construction licence No. A/176/11-12 dated 14/02/2012.
- 11. The construction work should be carried out as per approved plans.
- 12. To abide terms and condition of both SGPDA Revised order No. SGPDA /P/5332/1190/12-13 dated 18/09/2012 and Municipal Bye Laws.




