Licence is hereby granted to you in pursuance of Resolution No. 3(4) duly approved by the Village Panchayat in its meeting dated 15-02-2020 for carrying out the proposed construction of Residential cum commercial building, swimming pool and compound wall (Revised Plan) in Sy. No. 87/14-A, of Sangolda Village subject to the following conditions:-

1. The applicant shall notify the Panchayat for giving the alignment of the building.

2. The construction should maintain the minimum prescribed horizontal and vertical clearances from any overhead electrical line passing adjacent to the construction.

 All RCC/Structural works shall be designed and supervised by the Engineer who has signed the structural Liability Certificate submitted to the Panchayat.

4. No material for construction or earth from excavation or any other construction material shall be stacked on the Public roads.

5. The Building should not be occupied unless the occupancy certificate is obtained from the Panchayat.

6. The construction shall be strictly as per the approved plans. No change shall be effected in the approved plans/approved built spaces without the prior permission of TCP

7. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.

8. The applicant should construct a separate soak pit in order to derivate in the sullage water.

9. The Septic Tank, soak pit should not be located within a distance of 15.00 meters /as per the requirement of Health Act from any other existing well in the plot area/plan.

10. The ventilation pipe of the septic tank should be provided with a mosquito net.

11. The Applicant should connect the pipelines from their latrines/we's to the sewerage line at their own cost, when the sewerage line is commissioned.

12. The Applicant should fix a board at a prominent place whenever the construction is started indicating the number, the date and the authority for which the licence for development work has been granted.

13. The Developer /applicant should display a sign board of minimum size of 1.00 Mts X 0.50 Mts, with writing in black color on a white background at the site, as required under the Regulations.

14. All the building material and other rubbish should be cleared from the construction site before applying for the Occupancy certificate.

15. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.

16. Water storage tanks shall be provided with mosquito proof lids and over flow pipes, the tanks should be provided with access ladders wherever necessary.

17. The drains surrounding the plot if any should be constructed with PCC and should be covered with removable RCC slabs of sufficient thickness.

18. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.

19. The applicant should gift the road widening area to the Village Panchayat before applying for the occupancy certificate, if the applicant has utilized the extra FAR in lieu of the road widening affecting the plot.

 The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.

21. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the Commencement of any development/construction as per the permission granted by this order.

22. Completion Certificate has to be obtained from the Authority before applying for Occupancy Certificate from the licensing authority.

23. The applicant should plaster and paint the building internally as well as externally before applying for occupancy certificate. Exposed rick/laterite /concrete/stone/ ashlars masonry finish to buildings will also be permitted.

24. Adequate utility space for the dustbin, transformer etc. should be reserved within the plot area.

25. The Ownership of land if any of the property shall be verified by the licensing body before issuing of the license.

26. The applicant should provide a dustbin at a convenient place accessible for the Panchayat vehicle for collection of garbage.

27. The area under road widening shall not be encroached enclosed.

28. The height of the part compound wall strictly maintained as per rules in force.

29. The gate of compound wall shall be open inwards only.

- 30. In case of any culting of sloppy land or filing of low-tring falls, between permission of the Chief Town Planner shall be abstained before the commencement of the works per the provisions of Section 17(A) of the Goa foreper Country Manning Sect. 1974
- 31. The applicant should maintain all existing natural drains to the plot and should not about the mat any
- 32. In case of compound walls, the gates shall open inviteds only and traditional across, if any passing through the property shall not be blocked.
- 33. The applicant shall plant one tree for every 100.00 m2 of area developed, fand scaping on open spaces/tree plantation along roads and in developed plots.
- 34. Adequate arrangement shall be made for disposal of solid and liquid waste generated within the plot shall arrange to satisfaction of Village Panchayat.
- 35. Adequate storm water network shall be developed to the satisfaction of Village Panchayat and same to be connected to the existing drain in the locality.
- 36. The construction of compound wall should not obstruct any pathway or any public access. The applicant shall make necessary arrangements for smooth flow of rain water by keeping adequate openings in the compound wall for the purpose.
- 37. Labourers to be provided with basic amenities like proper shelter, water for drinking and domestic proposes, proper sanitary conditions including toilet facilities.
- 38. Drains /Nallahs to be maintained clean around the site so that there is no blockade to flow of water. The gradient should be proper for drainage/flow and also proper cleaning of water should be done.
- 39. The Health units at the respective levels should be involved in the planning process.
- 40. Panchayat shall verify the infrastructural requirements such as water and power before issue of construction license.
- 41. Applicant shall make his own arrangement of water requirement for swimming pool.
- 42. The village Panchayat shall take cognizance of any issue in case of any complaints court orders before issuing of construction license.
- 43. The technical clearance is issued in partial modification to the earlier approval granted vide no. TPB/2464/TCP-16/3071 dtd. 19/10/2016
- 44. The technical clearance is issued based on the Government approval vide Note No. TPB/2464/SAN/TCP-19/4994 dtd. 04/11/2019
- 45. The Technical clearance is issued for compound wall for length of 227.65 counting and confy
- 46. The said building should be used for residential purpose only as per the Technical Clearance Order.
- 47. All the conditions stipulated in the Technical clearance order bearing No. TPB 2464 SANG-TCP-19/5949 dated 04-12-2019 from TCP should be strictly followed.
- 48. The waste generated during the course construction/repair renovation etc. shall be disposed off by the applicant/s in a scientific manner without harming the environment in its own property.
- 49. The information furnished by the applicant for obtaining the permission for construction of Residential cum commercial building, swimming pool and compound wall in Sy. No. 87/14-A of Sangolda Village if found to be false at later stage, or if the conditions stated herein above are not complied with, the permission issued shall be liable to be withdrawn without pre-judge to the legal action that may be taken against the applicant.
- 50. Applicant shall dispose the construction debris at his own level and/or the same shall be taken to the designated site as per the disposal plan given by the applicant in the Affidavit at his own expenses
- 51. Applicant shall produce the certificate issued by the concerned PWD officials of designated sites as mentioned in the said Notification dated 07/03/2018.
- 52. Failing to comply clause (a) and (b) the penalty shall be imposed to the Applicant at the case of 0.5% on the total cost of the project and also the construction licence issued to the Applicant shall be withdrawn/cancelled.
