Whereas an application has been made to the Collector of Goa (hereinafter referred to as "the Collector" which expression shall include any Officer whom the Collector shall appoint to exercise and perform his powers and duties under this grant) under Section 32 of the Goa, Daman and Diu Land Revenue Code, 1968 (hereinafter referred to as "the said Code" which expression shall where the context so admits include the rules and orders thereunder) by Smt. Telma D'Souza r/o Gomes Catao Complex, Rajwado Mapusa Goa being the occupant of the plot registered under Survey No. 62/2-A(Part) of P.T.S. No. 13 situated at Cuchelin, Mapusa Bardez, Goa registered under No. Survey No. 62/2-A(Part) of P.T.S. No. 13 (hereinafter referred to as "the applicant" which expression shall, where the context so admits include his/her heirs, executors, administrators and assigns for the permission to use the plots of land (hereinafter referred to as the "said plot") described in the Appendix I hereto, forming a part of Survey No. 62/2-A(Part) of P.T.S.  - (b) Notwithstanding anything contained in sub clause (a) it shall be lawful for the Collector to direct the removal or alteration of any building or structure erected or use contrary to the provisions of this grant within such time as specified in that behalf by the Collector, and on such removal or alteration not being carried out and recover the cost of carrying out the same from the applicant as an arrears of land revenue.
