


AFFIDAVIT CUM DECLARATION

I, MR. JITENDRA GOVIND DEWOOLKAR Director of M/S. PLANET INFRAPLAN PRIVATE LIMITED age 50 an Indian national, being promoter of the proposed Project Named "TRIDENT" at "CAZRO SORVO" also known as "CAZREACHO SORVO" surveyed under Chalta No. 22 of P.T Sheet No. 17, situated at Karaswada, Hapusa, Bardez, Goa., do hereby solemnly declare, undertake and state as under:



 That I/promoter have /has a legal title report to the land on which the development of the project is to be carried out. And a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

That the project land is free from all encumbrances.

That the time period within the project shall be completed by me is on or **before** 31/12/2026;

- (a) That seventy per cent of the amount realised by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and lands cost and hall used only for that purpose.

That seventy per cent of the amounts to be realized here in after by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 5. That the amounts from the separate account shall be withdrawn in accordance with section 4 (2) (i) (D) read with rule 5 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017.
- 6. That I/the promoter shall get the account audited within six months after the end of every finance year by a practicing Chartered Accountant, and shall produce a statement of account duly certified and sighed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliances with the proportion to the percentage of completion of the project.
- 7. That I/the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That I/the promoter shall inform the authority regarding all the changes that have occurred in the information furnished under Sub-section (2)of action 4 of the Act and under rile 3 of these rules, within seven days of the said changes occurring.
- That I/the promoter have/has furnished such other documents as have been prescribed by the rules and regulation made under the Act.
