


In terms of resolution no. 5/2(12) taken in panchayat meeting dated 02.02.2016 as per the plans in triplicate / duplicate attached to his application under inward number 1546 dated 25.01.2016 on copy of the plans concerned with the approval note carrying the embossed seal of this panchayat and duly signed, is returned to the interested party, who shall comply with the following conditions:

1. To limit himself/herself to the plans approved and statement therein.
2. The construction shall be as per plans approved by this panchayat and conditions imposed on it.
3. To inform the panchayat after excavation and before laying or plinth foundation.
4. To inform the panchayat when the construction has been completed upto the plinth level.
5. To inform the panchayat as soon as the construction is complete.
6. Not to inhabit the building without the prior permission of this panchayat.
7. To abide by the other relation provision in force.
8. That building or construction is carried out as per the alignment given in the plinth level fixed by the panchayat.
9. The construction license shall be revoked in case of any document found false.
 - a. If the construction work is not executed as per the plans approved and stated therein.
 - b. Wherever there is any false statement or any misrepresentation of any material passed approved or shown in the application on which the permit was passed.
10. The concern party should follow all the conditions from 1 to 18 mentioned in the office of the Town & Country Planning Department, Ponda – Goa Ref. No. TPP/112/Adcolna/3/2015/407 dated 10.06.2015.
11. The license shall be liable to treat currying water that antilarval.
12. The concerned party should make the own arrangements for disposal of garbage.
13. The concern party should obtain the sanad conversion letter to this office within one year from the date of issue of license other wise license will be revoked without intimation to you.
14. The concern party shall not occupy the building unless occupancy certificate issued from this panchayat.
15. The construction license issued is liable to be withdrawn if any conditions stipulated in the above license are not completed with.
16. Labourers possessing health cards are only to be allowed to engage for work to come on the site.
17. Soak pit, Septic Tank should be away from the distance of 15 mtrs from the existing Drinking water well.
18. Non Biodegradable waste generated during the course of construction should be disposed in proper manner and it should not obstruct the vehicular traffic.
19. NOC from health should be produced to this office before start of work.
20. PWD or private engineers NOC/Estimate should be produced

The license shall be valid for the period of three year beginning from today. He has paid the fees respective to the tune of Rs. 63265/- vide receipt no. 027/95 dated 14.03.2016
