- IV. The promoter has deposited 100% of advances received amount in RERA designated account instead of 70% of advances received amount as required under Goa RERA. The promoter has also deposited Promoters Contribution/capital/loans/amount received for other projects of the firm, etc in RERA designated account apart from advances received for the project ADHIRAJ IMPERIAL GREENS. All the expenditure of the firm including the expenditure not related to the project ADHIRAJ IMPERAIL GREENS have been booked/incurred through RERA designated account, hence in this report/certificate for the purpose of computing the amount withdrawn we have considered the expenditure incurred only for the project ADHIRAJ IMPERIAL GREENS.
- V. The amount withdrawn/expenditure incurred from designated RERA account upto 31/03/2021 is the sum of total expenditure incurred on the project ADHIRAJ IMPERIAL GREENS, from the commencement of the project in the September 2017 till 31/03/2021.
