Description of the Immovable Property:

A) Property under scrutiny:

The property under scrutiny is the property known as "Sodoim" admeasuring 3625.00 sq. metres along with the residential house bearing House No. 817/B.

The landed property and the house taken together is hereinafter referred to as the "Said Property".

B) Location:

The Said Property is situated at Sodovim of Village of Verna, within the local limits of Village Panchayat of Verna-Nagoa, Taluka and Sub-District of Salcete, District of South Goa, State of Goa, not described in the Land Registration Office.

The Said Property now an independent and separate unit in itself erstwhile formed southern part of the property known as "BIRBIREM" enrolled in the Taluka Revenue Office under Matriz No. 802.
