- 8. That I shall inform the Authority regarding all changes that have occurred in the information furnished under sub section (2) of section 4 of the Act and under rule 3 of the Sail Rules, within 7 days of the said changes occurring.
- 9. That I have furnished such other document as have been prescribed by rules and regulation made under the Act.


