4. Pipeline of required diameter connecting meter box & P.W.D. distribution pipeline should be laid by the Owner / Developer / Consumer under the supervision of this department.

5. Sump of required capacity shall be constructed away from the P.W.D. distribution pipeline.

6. No encroachment in the departmental acquired area will be entertained and the boundry towards the departmental acquired area shall be districtly marked/fenced.

7. The permission is liable to be revoked at any stage, if the information/calculations. Submitted is found false.

8. Releasing this N.O.C. does not make this department liable for releasing Water Connection. The procedure towards availing Water Connection shall be complied separately.

9. The water connection is liable for disconnection, if the tap water is found to be used for said construction.

With reference to the above cited letter, this is to inform you that this office has No Objection for Proposed construction of Residental Building with Compound Wall in survey no. 16/6-K of Bordem, in Bicholm Taluka by Shri Paresh Pal.subject to below mentioned condition.

- 1. While issuing N.O.C. for construction of Tower / shelter / room they should put the condition restricting the owner from planting of trees in such a way that they are likely to endanger electrical lines when trees grow big.
- 2. The minimum vertical and horizontal clearance buildings/structure and the electrical line passing over or adjacent to the building/structure shall not be less than that specified in Rule 79 & 80 of Indian Electricity Rules 1956 amended time to time.
- 3. As per Clause 4(a) of condition of supply of Electrical Energy where multiple connections are to be released, the owner/promoter of the building should provide a build-up premises of 2 x 3 Sq. Mtr. With locking arrangement located nearest to public road on ground floor to put up the metering arrangement. In addition required open space/way leave should be provided for erection of over head H.T./L.T. Lines and transformer Centre.

Further work should be executed as per the plan submitted and adequate clearance should be maintained before and after the proposed construction.

One copy of plan is retained by this office and the original is enclosed.

Sub:- Issue of NOC for proposed Construction of residential Building with compound wall.

Sir,

With reference to the letter received from Mr. Paresh Pundalik Pal dated 30:12/2019 for the **proposed construction of residential house with compound wall**. Sy No. 16'6-K Bordem Village Bicholim Goa, on the above mentioned subject site inspection was undertaken by the undersigned of this Community Health Centre Bicholim on 02/12/2019 at 3.30pm. In this regards, I am to inform you that there is "NO OBJECTION from SANITARY POINT OF VIEW for the proposed **construction of residential house with compound wall** property bearing Survey No.16/6-K, situated at Bordem Bicholim, Goa, subject to the following conditions:

01. The construction shall carry out as per the plan submitted.

02. Proper cleanliness shall maintain in and around the construction site.

03. The soak pit and septic tank should be at least fifteen meters away from any drinking water source and should correspond with the dimensions given.

04. The capacity of septic tanks should correspond with dimensions shown in the chart submitted to this office for 100 persons. Two soak pits should be constructed for sullage & swage water separately.

05. No health hazard or any other environmental pollution shall be created in the surrounding area.

06. The owner/contractor shall co-operate with the health and pollution control authorities whenever they visit the site for inspection.

07. This office is not responsible for any litigation in any court regarding the ownership and area of the plot/house.

08. If there is any complaint from the sanitary point of view, the N.O.C. will be revoked.

09. As per section 75A of Goa Public Health Act all labourers should possess health cards and should renew them once in three months. Whoever contravenes the provision of the Public Health Act shall be punishable with fine as specified in the Act and amendments published in the official Gazette Government of Goa, Series 1 No.26 (Extraordinary No.3). Labourers/workers engaged by contractor developer/ builder without health card shall be fined@ Rs. 10000/- per labour.

10. Anti larval activities (spraying of telephone 2.5 ml diluted in 10lts of water should be carried out by the builder/contractor with the help of designated person once a week at the construction site.

11. Sanitation facilities including safe drinking water should be provided at the construction site, ensuring sage disposal of domestic waste water.

12. Antenatal mothers and childrens on the construction site should be timely immunized at the health facilities and should be provided with mosquito nets

13. Health cards should be available at the site and should be produced to the Health Authority on demand.

14. The ownership of the property shall be verified by the licensing body before the issuing of the license.

15. Final N.O.C. from Health Authorities is to be obtained prior to issuance of occupancy certificate.

16. A signboard should be displayed on the site with the details such as name of the builder Phone No. and license number of all appropriate authorities.

17. The NOC shall stand withdrawn if the documents submitted to this office are found to be invalid/incorrect/false/forged.

18. The N.O.C. is liable to be withdrawn if the conditions stipulated above are not complied with
