



AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr Mario Fernandes, his office at Office No 6, Comunidade Ghor, 2nd Floor, Angod, Mapusa Goa, promoter of the project named "**PIOS ANNEXE**" represented herein by the promoter of the proposed project, Mr Mario Fernandes son of Constancio Fernandes, aged 53 years, married, businessman, resident of H NO 242/2A, St Jerome vaddo, Opp Galaxy Hospital, Duler, Mapusa, Goa.

I do hereby solemnly declares, undertake and state as under:-

- (1) That I have a legal title to the plot surveyed under Chalta No 51-A PT Sheet No 52 of City of Mapusa, on the land on which the development of the project namely "**PIOS ANNEXE**" is proposed.
- (2) That the project land is free from all encumbrances.
- (3) That the time period within which the project shall be completed by is 10.01.27
- (4) That seventy per cent of the amounts realised by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- (5) That the amounts from the separate account shall be withdrawn in accordance with section 4 (2) (1) (D) read with rule 5 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on website) Rules, 2017.
- (6) That I/the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and

signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliances with the proportion to the percentage of completion of the project.

- (7) That I/the promoter shall take all the pending approvals on time, from the competent authorities.
- (8) That I/the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- (9) That I/the promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- (10) That I/the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
