That I/Promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered accountant and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amount collected for a particular project have been utilized percentage of completion of the project.
- 7. That I/ promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That I/the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under subsection (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
