COMPLETION ORDER


Completion is hereby certified for **construction of Residential Building** constructed as per the Technical Clearance granted by this Department vide Order no. **TPB/5886/PIL/TCP-2020/3076** dtd.13/08/2020 in Sy. No. 59/2, Plot No.24 of Village **Pilerne** Taluka Bardez subject to the following conditions.

1. The use of the Building should be strictly as per the approval.
2. All parking spaces/Garages should be used for parking of vehicles only and should not be converted for any other use.
3. No attachment/alteration to the building shall be carried out and the building shall not be occupied unless the occupancy certificate is obtained from the concerned Village Panchayat on presentation of this order.
4. As regards complaints, pertaining to encroachments, Judicial Order/directive and other legal issues, the same may be verified and confirmed by the concern Village Panchayat before issuing Occupancy Certificate.

Note:-

- a) This Completion Order is issued based on the completion certificate issued by project **Architect Prashant D. Gaonkar** dtd. 14/04/2022 having Reg. No. **AR/0064/2010**.
- b) This Completion Order is issued based on the Structural Stability Certificate issued by project **Engineer Venkatesh P. Pai** dtd. 19/04/2022 having TCP Reg. No. **ER(DIP)/0008/2019**.
- c) The Completion Order issued is from the planning point of view only. As regards to the structural stability and safety of all, concerned owner and his Engineer shall be solely responsible and the Town Planner and his all officials are indemnified and kept indemnified forever against any civil and criminal liabilities and for any kind of liability, whatsoever in the event of any untoward incident or structural failure/collapse.
