

Affidavit cum Declaration

- I, Sandip Rohidas Adpaikar, Age 53 Residing At h.no 110, malbhat, margao, goa. near apollo hospital, goa promoter of the proposed project do hereby solemnly declare, undertake and state as under:
- 1. That I have a legal title to the land on which the development of the project is proposed. And have legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.

- 3. That the time period within which the project shall be completed by us/promoter is 20.04.2028
- 4. That seventy per cent of the amounts realised by us/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

That I / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That I shall take all the pending approvals on time, from the competent authorities.
- 8. That, the promoters shall inform the Authority regarding all the changes that have occurred in the information furnished under sub section (2) of the section 4 of the act and under rule 3 of the said rules within seven days of the said changes occurring.
- 9. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That I / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
