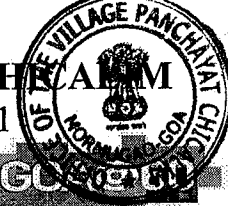

**Subject to the following conditions:**

1. All conditions stipulated in the completion certificate bearing No. MPDA/9-S-236/2023-24/1198 dated 17/01/2024 should be strictly adhered to.
2. This Occupancy Certificate shall be treated as NOC for obtaining Water and Electricity connection.
3. The Applicant has to take all the necessary NOC /approval from all the concern Dept. whichever applicable before the Occupying the premises.
4. Consent to Establish granted by Goa State Pollution Control Board vide No. 12/2023-PCB/1645477/G00011975 dated 02/08/2023 should be strictly adhered to.
5. Applicant should make independent provision for Garbage disposal within the Plot Area by constructing Composting Unit and intimate this office accordingly and also dispose the Garbage properly in scientific manner. Further, follow all the provision of Solid Waste Management Rules 2016 for collection, segregation, transportation, Storage and disposal while be under your managements.


