- 5. That amounts from separate account shall be withdrawn in accordance with Rules framed by State Government.
- 6. That I / promoter shall get accounts audited within six months after end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during audit that amounts collected for a particular project have been utilised for the project and withdrawal has been in compliance with proportion to percentage of completion of the project.
- 7. That I / promoter shall take all approvals on time from competent authorities.
- 8. That I / promoter have / has furnished such other documents as have been prescribed by rules and regulations made under the Act.
