J U D G M E N T

(Delivered on this the 24th day of the month of November, of the year 2003).

This Inventory Proceedings has been instituted by the Inventariante/Applicant upon the death of his parents, namely, late Nagesh Krishna Naik and his wife Chandrabhaga Naik passed away intestate, the former died on the 21st October, 1974 and the latter died on 21-5-1969, for the partition of the estate left by the said deceased persons. The said deceased persons were married under the regime of Communion of Assets.

2. The Inventariante/Applicant being one of the legal heir of the deceased persons has been appointed as "Cabeca de Casal" by the order of the Court dated 3rd October, 2003 and, accordingly, his statement on oath came to be recorded on 13th October, 2003, in which he disclosed that the estate leavers have left behind them the following heirs/children/grand children, being their sole and universal heirs:

- a) Mr. Manohar Nagesh Naik, bachelor,
resident of Alto Duler, Mapusa-Goa;
- b) Mr. Balaji Nagesh Naik, married to
Mrs. Indira Balaji Naik,
both residents of Malad (East),

resident of Alto Duler, Mapusa-Goa;

- d) Mr. Ramakant Nagesh Naik, bachelor,
resident of Old Bazar, Ponda-Goa;
- e) Mrs. Ratnaprabha Dayanand Kantak,
married to Mr. Dayanand Govind Kantak,
both residents of Pajifond, Margao-Goa;
- f) Mr. Krishna Nagesh Naik alias
Prakash Naik, married to
Mrs. Sindhu Krishna Naik,
both residents of Feira-Baixa, Mapusa-Goa;
- g) Mr. Arvind Nagesh Naik, married to
Mrs. Neera Arvind Naik,
both residents of St. Inez, Panaji-Goa;
- h) Mr. Subhash Nagesh Naik, married to
Mrs. Suchita Subhash Naik,
both residents of Alto Duler,
Mapusa-Goa;
- i) Hemlata Kush Pai, married to
Mr. Kush Tulsidas Pai. The former expired
leaving behind her widower the said Kush
Tulsidas Pai and the following children:
- (i) Mr. Sudesh Kush Pai, unmarried,
resident of Navelim, Salcete-Goa;
- (ii) Mrs. Swati Moreswar Porobo Deshpabhu,
married to Mr. Moreswar Anandrao

of Porvorim, Bardez-Goa;
- (iii) Mrs. Chitra Govind Prabhu Gaonkar,

3. Shri Kush Tulsidas Pai, husband of late Hemlata Pai has relinquished his rights under/vidē Article 2029 of Portuguese Civil Code, 1867, on the 5th of April, 1982. A copy of which is filed on record.

4. The Inventariante/Applicant in his statement states that, besides the above heirs, the deceased persons have not left any more heirs either ascendants or descendants, nor they have left any creditors or legatees who can claim the inheritance left over by the said deceased persons.

5. The Inventariante/Applicant also states that the deceased persons have left some immovable assets and they are situated at Mulgao, Bicholim and Mapusa. A detailed list of the said assets was produced by him at the time of recording the statement, and the same was placed on record.

On the basis of the said list submitted by the Inventariante/Applicant, this Court has drawn the description of the Assets of Item No.I to Item No.V on 3rd November, 2003, which reads as under:-

"DESCRIPTION OF ASSETS

On 3rd day of November, 2003, at Ponda and in the Court of the Civil Judge, Senior Division, Ponda, I, Smt.Jasmina Dias, U.D.C. of the Court have drawn the description of Assets, left behind by the above deceased Nagesh Krishna Naik and his wife Chandrabhaga Naik, taking into consideration the list of Assets



produced by the "Cabeca de Casal" and in view of the Order passed by this Hon'ble Court in the following manner:-

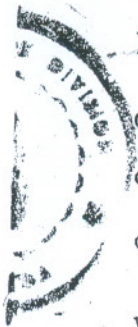

And as there are no more items to be described, I close the description and hence this proceedings is placed before the Court for further orders."

7. During the course of the proceedings, all the interested parties in the above matter have filed the "Consent Terms" alongwith the plans, wherein they have arrived at an amicable settlement among themselves for the purpose of partition and division of the properties:-

(2) PLOT NO.9 (NINE) of the property known as "DANDO" admeasuring an area of 476-50 square metres, surveyed under No. 54/4 situated in the village Bordem, within the jurisdiction of village panchayat of Bordem, Taluka and sub-District of Bicholim, District of North Goa, State of Goa, described under No. 3733 at pages 155, BookNo.B, volume 10 (new series) in the "Conservatoria de Registo Predial of Bicholim", and the said Plot No.9 admeasuring an area of 476-50 square metres is bounded on the North by the property surveyed under No.54/3 belonging to Laximan Narayana Dhond with the dimension of 17-50 mts., on the South by the property surveyed under No. 54/5 belonging to Ganesh Dhond with the dimension of 17-50 mts., on the East by Plot No.8, part of the same property surveyed under No. 54/4 belonging to the heirs of Nagesh Naik with the dimension of 28-50 mts. and on the West by the "Kulagar" of the Plantation of Arecanut and other fruit bearing trees belonging to Prakash Nagesh Naik of the part of the same property surveyed under No. 54/4 with the dimension of 27-50 mts.

(3) PLOT NO.9 (NINE) of the property known as "ELACHO KAS", admeasuring an area of 6005-90 square metres, surveyed under No.76/0, situated in the village Bordem, within the jurisdiction of Village Panchayat of Bordem, Taluka and sub-District of Bicholim, District of North Goa, State of Goa, described under No.13017 at page 158 reverse of Book No.B, Volume No.33 (New Series) in the "Conservatoria de Registo Predial of Bicholim" and the said Plot No.9 admeasuring an area



of 6005-90 square metres is bounded on the North by Plot No.8, part of the same property surveyed under No. 76/0 belonging to the heirs of Nagesh Naik with the dimension of 290-00 mts., on the South by the property surveyed under No. 77/0 belonging to Vassudev alias Vasant Baburao Naik and formerly belonging to Desai with the dimension of 278-00 mts., on the East by the property surveyed under No. 75/0 belonging to the Comunidade of Bordem-Bicholim with the dimension of 24-00 mts., and on the West by the property surveyed under No. 69/0 belonging to Jaivantrao Ravloba Vishwasrao Desai and Comunidade of Bordem-Bicholim with the dimension of 20-50 mts.

- III. It is specifically agreed between the parties that the partition/division hereby made has been admitted and confirmed by all the interested parties.
- IV. The parties hereto have resolved the dispute of accounts amicably and they have no claims whatsoever against each other.
- V. From the date of execution of the "Compromise Terms", each party shall be the exclusive owners of the plots allotted to each of them, and they cede, release, renounce, and relinquish all their rights, titles, interests and claims whatsoever over the others plots allotted to the other parties.
- VI. It is specifically agreed that this partition of the properties shall not be re-opened again,



but if at all required, the parties shall execute a fresh Deed of Conveyance among themselves.

- VII. It is specifically agreed between the parties that the final order passed by this Hon'ble Court in regard to the properties surveyed under -
- (A-1) Chalta No. 202, P.T. Sheet No. 146 at Mapusa, Goa;
 - (A-2) Chalta No. 68, P.T. Sheet No. 146 at Mapusa, Goa;
 - (B) Properties known as "BHATVADI" alias "BOTVADI COTTUMBINA MARGACODIL" surveyed under Nos. 258/2, 258/5, 259/0, 260/1, 260/2, 260/3, 261/1, 261/2, 261/3 and 261/4 at village Mulgao, Taluka Bicholim;
 - (C) Property known as "ELACHO KAS" surveyed under No. 76/0 at village Bordem, Taluka Bicholim;
 - (D) Property known as "DANDO" surveyed under No. 54/4 at village Bordem, Taluka Bicholim,
- shall be the legal document for all legal purposes and, if the parties intend to sell their allotted plots or enter into any other transactions, they shall do so of their own and at their own cost and expenses and no permissions or consents will be required from the other parties.

- VIII. The plans annexed to the "Compromise Terms" shall form integral part and parcel of the compromise.
- IX. It is hereby agreed that each party will execute such deed or do all other acts necessary which may be requisite for more effectually assuring the party so requiring and at his/their cost and expenses, in the manner required by law and appear before the Revenue or other officers to have mutation effected in respect of the plots assigned to the party concerned in the plans annexed hereto.
- X. That the parties hereto agreed that, any one of the party can do/develop or issue N.O.C. for the construction of internal road, construction of road side drainage, laying of culvert/pipes, erection of electrical/telephone poles, laying of telephone cables within the reserved road area which is reserved for the common use of the parties hereto.
- XI. That the parties hereto agreed to receive the Government road area compensation, which area has been left out on the plan for the proposed expansion of P.W.D. road (shown on the plans as road setback area), in common and to be divided in equal shares.
- XII. That the plots hereby allotted to the parties concerned shall be entered upon and henceforth held in severally by such party without any



interruption or disturbance by the other party or any one claiming them, under or in trust for it.

XIII. That the parties hereto do hereby agree and declare that the partition hereby made is just, fair and acceptable to them. They further state that in consideration of the partition made under this document with a view to maintain harmonious relations between all the parties inter-se, each member agrees without reservation to forgo all their rights and/or claims which they have acquired through any earlier Deed or document or inheritance or in any manner whatsoever.

8. The above consent terms and plans are signed by the "Cabeca de Casal" as well as all the interested parties alongwith their respective spouses.

9. I have gone through the entire records of the case, so also the partition deed and "Consent Terms" along with the plan filed by the parties and, as the parties have settled the matter amicably among themselves, I have no hesitation to accept the consent terms and allot to the parties the shares/plots as mentioned in the said "Consent Terms" vis-a-vis in the plan and which "Consent Terms" are confirmed and made absolute, for all legal purposes.

The Inspector of the City Survey, Mapusa, Goa, is hereby directed to execute the mutation of the said

The Mamlatdar of Bicholim and the Talathies of Mulgao and Borden, Taluka of Bicholim, are hereby directed to execute the mutation of the said properties and The Collector of North Goa, Deputy Collector and Sub-Divisional Officer of Bicholim is hereby directed to carry out Survey partition and separation of the respective properties within their jurisdiction on the basis and strength of this Court Order. And also the Sub-Registrar of Mapusa is hereby directed to register this Court Order under Registration Act, in view of the amicable settlement of the parties concerned.

Proceedings stand closed.
