- I. - IV. While certifying on utilization, we have relied on the expenditure as per books of accounts produced before us.
- V. Estimated cost for the calculation of % of completion is given by management.
- VI. Percentage of completion is calculated as per actual cost incurred as per books of accounts divided by the estimated cost to complete the project.
- VII. Villa no 3 was booked in the name of Suchit Dhawan which later cancelled in Quarter 1. The promoter has refunded the amount of Rs. 22,07,200/- from the main account instead of refunding 70 % amount of refund amount i.e Rs. 15,45,040/- from RERA Account. Therefore, we have reduced Rs. 15,45,040/- from amount withdrawn till date.
