## TECHNICAL CLEARANCE ORDER

Technical Clearance is hereby granted for carrying out the work of proposed construction of residential building -1 and villas -B1,B2, B3 and B4 as per the enclosed approved plans in the property zoned as Settlement Zone in Regional Plan for Goa 2001 and 2021 and situated in Plot no.\_\_of survey no 101 sub- division 2 of Raia Village of Salcete Taluka with the following conditions:-

- Construction shall be strictly as per the approved plans No changes shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
- The permission granted shall be revoked, if any information, plans calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
- The development permission will not entitle the applicant for netking/laying any claim on water and any other connection from the Government of Goa.
- The Developer/applicant should display a sign board of minimum size 1.00mts. x 0.50mts. With writing in black colour on a white background at the site, as required under the Regulations.
- The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the commencement of any development/construction as per the permission granted by this order.
- The soak pit should not be located within a distance of 15.00 meters from any existing well in the surrounding area.
- The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.
- Completion Certificate has to be obtained from this Authority before applying for Occupancy Certificate from the licensing authority.
- Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
- 10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
- 11. In case of any cutting of sloppy land of filling of low lying land are involved, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town and Country Planning Act, 1974
- 12. The Ownership of the property shall be verified by the licensing body before issuing the licence.
- 13. Verification of the tenancy position as on 2/11/1990 and the eafter shall be made by the list sing body before issuing the licence
- 14. The Ownership of the property shall be verified by the licensing body before issuing the licenses.

- 192 Verification of the tenancy ogsition as on 2/11/1990 and thereafter shall be made by the licensing body before issuing the license.
- 16. As regards complaints, peruning to encroachments, Judicial orders/directive and other legal issues, the same may be verified and confirmed by the concern Village Panchayat before issuing licence.
- 17. The set backs shown on the ske plan shall be strictly maintained.
- The Village Panchayer shall ensure about the availability of power and water supply and other required infrastructure before assuing licence
- 19 The area under rould widening shall be deemed to be public road and shall of be enclosed/encroached Affidavit / undertaking in this regard shall be sworn before the Municipal Council /PWD as the case may be on stamp paper of Rs.100/-.
- 20. This technical clearance order is issued relying on the survey plan submitted to this office from the concern authority in case of any boundary dispute /encroachment if any shall be resolved by the applicant with clear demandation of the boundaries from Survey Deaprtment. This office shall not held responsible analy point of time as the said technical clearance order is only from planning point of view.
- 21. Applicant shall dispose the construction debris at his/her own level and/or the same shall be taken to the designated site as per the disposal plan given by the applicant in the Affidavit to be produced to the corporation/Municipal Council/Village Panchayat (as the case may be).
- 22. No Part of the open terrace shall be allowed to cover. The proposal uses in the shops shall be for soft commercial process and the uses in the shops shall not cause nuisance in the locality.
- 23 This technical clerarance order is issued based on the approval granted by the Govt. vide note no. TPM/29741/Raia/101/2/19/1651 dated 01/03/2019
