TECHNICAL CLEARANCE ORDER

for carrying out the construction of Residential/ Technical Clearance is hereby granted Commercial building "A" (Shops & flats) and Residential building "B" as per the enclosed approved plans in the property zoned as Settlement Zone in Regional Plan for Goa 2021 and situated in survey no.225 sub.division no. 2-H of Nagarcem-Palolem Village of Canacona Taluka with the following conditions:-

- 1. Construction shall be strictly as per the approved plans No changes shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
- 2. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
- 3. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.
- 4. The Developer/applicant should display a sign board of minimum size 1.00mts. x 0.50mts. with writing in black colour on a white background at the site, as required under the Regulations.
- 5. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the commencement of any development/construction as per the permission granted by this order
- 6. The septic tank, soak pit should not be located within a distance of 15.00meters from any existing well in the surrounding area.
- 7. The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.
- 8. Completion Certificate has to be obtained from this Authority before applying for Occupancy Certificate from the licensing authority.
- 9. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
- 10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
- 11. In case of any cutting of sloppy land of filling of low lying land, are involved, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town and Country Planning Act, 1974.
- 12. In case of compound wall , the gates shall open inwards only and traditional access, if any passing through the property shall not be blocked.
- 13. The Municipality/Panchayat shall ensure about the availability of required portable water and power supply before issue of license.
- 14. Adequate arrangement for collection and disposal of solid waste generated within the plot shall arrange for satisfaction of Municipality/Panchayat.
- 15. Adequate storm water network shall be developed up to the satisfaction of Municipality/village panchayat and same to be connected to the existing drain in the locality.

- 16. The Municipality/Village panchayat shall take cognizance of any issue in case of any complaints/Court orders before issue of construction licence.
- 17. The applicant shall dispose the construction debris at his/her own level and the same shall be taken to the designated site as per the disposal plan given by the applicant in the Affidavit to be produced to the Municipality/village Panchayat.

18. The setbacks shown on the site plan shall be strictly maintained.

19. Required number of trees shall be planted by the applicant in the said plot/property as per the Regulation 18 of the goa Land Development and Building constructionRegulations, 2010 regarding landscaping of open spaces/trees planting along the roads and in develop plots.

20. This Technical Clearance Order is issued on the basis of Order dtd. 28/3/2018 and 6/4/2018 as per

Regional Plan for Goa 2021.

- 21. This Technical clearance order is issued relying on the survey plan submitted to this office from the concerned authority. In case of any boundary dispute encroachment if any shall be resolved 17 to applicant with clear demarcation of the boundaries from survey Department. This office shall not be held responsible at any point of time as the said technical clearance order is only from Planning point of view
 - 22. The area under road widening shall be deemed to be public road and shall not be enclosed/encroached Affidavit/undertaking in this regard shall be sworn before the Village panchayat/PWD as the case may be on stamp paper of Rs. 100/-.

23. Shops shall be used for soft Commercial purpose only.

24. This Order is issued based on the letter from Executive Engineer-XIV(NH) vide letter no. 2149/PWD/WD XIV(NH)ASW/2014-15/1506 dtd. 24/12/2014.

25. This Technical Clearence Order is issued based on the approval obtained from the Government. Vide note no. TPC/2233/Nag-Pal/225/2-H/2021/584 dtd. 13/12/2021.

THIS ORDER IS VALID FOR THREE YEARS FROM THE DATE OF ISSUE OF CONSTRUCTION LICENCE, PROVIDED THE CONSTRUCTION LICENCE IS ISSUED WITHIN THE PERIOD OF THREE YEARS
