- 3. We estimate Total Estimated Cost of completion of the building of the aforesaid project under reference as Rs. 5,54,81,082.00 (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building from the Village Panchayat under whose jurisdiction the aforesaid project is being implemented.
- 4. The Estimated Cost Incurred for building till date is calculated 32,13,388.00 (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.
- 5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building and Building(B) of the subject project to obtain Occupation Certificate / Completion Certificate from the Village Panchayat is estimated Rs. 2,87,52,234.00 (Total of Table A and B).
