The builder/owner of the construction/building society shall repair/re-construct the septic tank/soak pits, whenever there is leakage /overflow of sewage/sewage water from the said septic tanks/soak-pits failing which the electric /water supply of the premises shall be disconnected as per the provisions of Sub. Section (5) of Section 40 of Goa Public Health Act, 1985 & Rules, 1987.
- 5. The NOC issued is liable to be withdrawn if the conditions stipulated above are not complied with.
