2. We have obtained all necessary information and explanation from the Promoter, during the course of our audit, which in our opinion are necessary for the purpose of this certificate.
3. We hereby confirm that we have examined the prescribed registers, books and documents, and the relevant records of “**K K INFRA PROJECT**” for the period ended **01.04.2023 to 31.03.2024** and hereby certify that-
  - i. The Promoter has/have completed **30%** of the project titled “**K K AVENUE**” bearing Goa RERA Reg. No. **PRG003231940** located at **SURVEY NO. 280/2-A, SITUATED AT TIVIM, BARDEZ, GOA, Bardez, North Goa.**
  - ii. Amount collected during the year in question for this project for the financial Year **2023-24**, In Specified designated A/c Rs. 4,35,57,851/-, and amount collected till date (Up to **31.03.2024**) is Rs. 4,35,57,851/-
  - iii. Amount withdrawn during the year for (Year)**2023 -24** is, from Specified designated A/c Rs. 4,15,95,000/-, and amount withdrawn till date (From start of the project up to **31.03.2024**) is Rs. 4,15,95,000/-

We certify that “**K K INFRA PROJECT**” has utilized the amounts collected for “**K K AVENUE**” project only for that project and the withdrawal from the designated bank account of the said project has been in accordance with the proportion to the percentage of the completion of project. **Exceptions**

Further the said certificate has been issued on the basis of limited review of the books of accounts and not on the basis of any site visit done as we are not technically qualified to perceive the progress of work on site for which we rely on the Architect certificate dated 17<sup>th</sup> March 2025 for completion of work on site.
