**TECHNICAL CLEARANCE ORDER**

Ref No: Inward No.1070

Dated: 02/03/2022.

Technical Clearance is hereby granted for **proposed construction of Residential Villas (Type -A =18 nos.), ( Type -B =7 nos), (Type -C =10 nos), Swimming pools and construction of Commercial cum Residential building comprising of shops and Penthouse (10 nos.) Club house & compound wall (Revised plan)** as per the enclosed approved plans in the property Zoned as **‘Settlement Zone’ in Regional Plan for Goa 2021** situated in Survey No.31/1-A-1 (Part), Plot-A at **Pilerne Village, Bardez- Goa,** with the following conditions:-

1. Construction shall be strictly as per the approved plans. No change shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
2. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
3. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.
4. The Developer/applicant should display a sign board of minimum size 1.00 mts. X 0.50 mts. with writing in black color on a white background at the site, as required under the Regulations.
5. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the Commencement of any development/construction as per the permission granted by this order.
6. The Septic Tank soak pit should not be located, within a distance of 15.00 meters / as per the requirement of Health Act from any other existing well in the plot area/plan.
7. The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.
8. Completion Certificate has to be obtained from this Authority before applying for Occupancy Certificate from the licensing authority.
9. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
11. In case of any cutting of sloppy land or filling of low-lying land, beyond permissible limits, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town & Country Planning Act, 1974.
12. The ownership of the property shall be verified by the licensing body before the issuing of the license.




13. The adequate arrangement for collection and disposal of solid waste generated within the complex shall be arranged to satisfaction of Village Panchayat.
14. Panchayat shall verify the infrastructural requirements such as water and power supply before issue of construction license.
15. Adequate storm water network shall be developed up to the satisfaction of Village Panchayat and same to be connected to the existing drain in the locality.
16. The area under road widening shall not be encroached/ enclosed.
17. The said building should be used for residential/commercial purpose only as per the Technical Clearance Order.
18. Gradient of the ramps to the stilt floor parking should not be exceed 1:6.
19. Applicant shall plant one tree for every 100.00m<sup>2</sup> of area developed, land scaping on open spaces/tree plantation along roads and in developed plots.
20. The Village Panchayat shall take cognizance of any issue in case of any Complaints court orders before issuing of construction license.
21. The height of the compound wall strictly maintained as per rules in force.
22. Gate of compound wall shall be open inwards only.
23. Applicant shall make his own arrangement of water requirements for swimming pool.
24. This Technical Clearance is issued in partial modification to the earlier approval granted vide no. TPBZ/60/PIL/TCP-2022/63 dtd. 04/01/2022.
25. All the conditions imposed in our Technical Clearance issued by this office vide letter no. TPBZ/60/PIL/TCP-2022/63 dtd. 04/01/2022 should be strictly adhered
26. Applicant shall dispose the construction debris at his/her own level and/ or the same shall be taken to the designated site as per the disposal plan given by the applicant in the affidavit to be produced to the village Panchayat.
27. This Technical Clearance Order is issued based on the concurrence of Chief Town Planner (Planning).

- a) This Technical Clearance Order is issued based on the order issued by the Secretary (TCP) vide no. **29/8/TCP/2018 (Pt.File)/1672** dated **13/08/2018** pertaining to guide line for processing various application.
- b) An engineer who designs the RCC structure, of the project proponent is liable for structural designs and stability of the project, structural liability certificate issued by an **Engineer Pascoal B. Noronha** dtd. **12/02/2022** TCP Reg. No. **SE/ 0032/2010**.
- c) This order is issued with reference to the application dated **02/03/2022** from **M/s. Ave Miriam Resorts Private Limited**.
- d) Applicant has paid Additional infrastructure tax of **Rs.1,39,252/- (Rupees One Lakh Thirty Nine Thousand Two Hundred Fifty Two Only)** vide challan no. **623** dated **15/03/2022**. Earlier applicant has paid Infrastructure tax **Rs.38,00,892/-** vide Challan **NO.374** dtd. **19/01/2017** an **Rs. 5,63,710/-** vide Challan No. **433** dtd. **04/01/2022**.

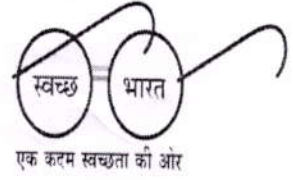

Whereas the infrastructure tax towards your application for **proposed construction of Residential Villas (Type - A= 18nos), (Type-B =7 nos), (Type - C = 10 nos), alongwith swimming pools and construction of commercial cum Residential building comprising of shops and penthouse (10 nos) and club house (Revised plan)** in property bearing Survey No.31/1-A-1 (part), Plot A of Village Pilerne Taluka has been assessed as **Rs.1,39,252/- (Rupees One lakh Thirty Nine Thousand Two Hundred Fifty Two Only)**. The calculation of the tax has been assessed @ **Rs.200/-** per square meter of **Residential floor area** as per the provisions of the said Act.

**Infrastructure Tax Calculation:**

Additional built up area for Residential purpose = 696.26m<sup>2</sup> X Rs. 200/- =Rs. 1,39,252/-
