### Affidavit cum Declaration

Affidavit cum Declaration of **Mr. Vinaykumar Vinayak Fulari**, Director of RVJ Trading Private Limited, Developers of the project named "B&F Whispering Glenz". I, Mr. Vinaykumar Vinayak Fulari, Son of Vinayak A. Fulari, aged 48 years, Indian national, Developer of the proposed project/duly authorized by the Owners of the proposed project do hereby solemnly declare, undertake and state as under:

- (1) That we are the Developers of the land/project and have a legal title Report to the land on which the development of the project is proposed.
- (2) That the project land is free from all encumbrances.
- (3) That the time period within which the project shall be completed by us/developers from the date of registration of project; is 30/10/2026;
- (4) For new projects: That seventy per cent of the amounts realised by us/developers for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- (5) That the amounts from the separate account shall be withdrawn in accordance with section 4 (2) (I) (D) read with rule 5 of the Goa

Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017.

- (6) That we the developers shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- (7) That we the Developers shall take all the pending approvals on time, from the competent authorities.
- (8) That we the Developers shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- (9) That we the Developers have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- (10) That we the Developers shall not discriminate against any Allottee at the time of allotment of any apartment, plot or building, as the case may be.
