APPENDIX - C4 CONSTRUCTION LICENCE

License is hereby granted for carrying out the:-

- *(a) Land Sub Division (Provisional/Final)
- * (b) Re-Construction of Residential house
- * (c) Construction of Residential and Commercial Building 'A' and Residentail Building "B" and Compound wall.
- * (d) Change of use of (Building/Land)/as per the enclosed. As per the enclosed approved plans in the property zones as "Settlement Zone" VP-1, FAR 80% as per Regional Plan for Goa 2021, Situated in Survey No. 52/1-A (Part). Situated at Tivrem Village of Ponda Taluka, - with the Following conditions:-
 - 1. The applicant shall strictly comply all the conditions imposed in the Development Permission/Order No. TPP/641/Tivrem/52/1-A/2024/1845. Dated 31/07/2024 issued by the Dy. Town Planner. Planning and Development Authority/Technical Clearance Order/ Corrigendum issued by the Town and Country Planning Department, Ponda - Goa.
 - The applicant shall strictly comply all the conditions imposed by Primary Health Centre, Betki vide no. DHS/2024/DHS0901/00055/49 dated 07/08/2024
 - The applicant shall notify the Panchayat for giving the alignment of the building. 3
 - The Construction should maintain the minimum prescribed horizontal and vertical clearances from any overhead electrical line passing adjacent to the Construction.
 - All ACC/Structural works shall be designed and supervised by the Engineer who has signed the structural liability Certificate submitted to the Panchayat.
 - No Material for Construction or Earth from excavation or any other Construction material shall be stacked on the Public roads.
 - The building should not be occupied unless the Occupancy Certificate is obtained from the Panchavat.
 - The Construction Licence shall be revoked if the Construction work is not executed as per the approved plans and the statements there in and whenever there is any false statement or misrepresentation of any material passed, approved or shown in the application on which the permit was based.
 - The applicant soak pit should construct a separate in order to derivate in the sullage water.
 - 10. Any soak pit should be constructed at a minimum distance if 15 meters away from any well.
 - 11. The ventilation pipe of the septic tank should be provided with a mosquito net.
 - 12. The Applicant should connect the pipelines from their latrines/WC's to the sewerage line at their own cost, when the sewerage line is commissioned.
 - 13. The applicant should fix a board at a prominent place whenever the Construction is started, indicating the number, the date and the authority for which the licence for development work has been granted.
 - 14. All the building material and other rubbish should be cleared from the Construction site before applying for the Occupancy Certificate.
 - 15. Water Storage tanks shall be provided with mosquito proof lids and over flow pipes. The tanks storage shall be provided with access ladders wherever necessary.
 - 16. The drains surrounding the plot if any should be constructed with PCC and should be covered with removable RCC slabs of sufficient thickness.
 - 17. The applicant should gift the road wide widening area to the Village Panchayat before applying for the Occupancy Certificate, if the applicant has utilized the extra FAR in lieu of the road widening affecting the plot.
 - 18. The applicant should plaster and paint the building internally as well as externally before applying for occupancy certificate. Exposed Brick / laterite / concrete / stone / ashlars masonry finish to building will also be permitted.
 - 🔄 9. The applicant should provide a dustbin at a convenient place accessible for the Municipal Vehicle for Collection of Garbage.
- 20. Road widening area shall be asphalted to the existing road level before applying for Occupancy SECRETA Gerificate.

- 21. Garages and Parking areas shown in the approved plan shall be strictly used for parking purposes only and should be easily accessible to vehicles. No commercial activities shall be allowed in these
- 22. Access up to the entrance of the building is to be paved and with drainage facilities.
- 23. Space for Parking of vehicles is clearly demarcated on the ground.
- 24. No Commercial activities will be permitted in the shops unless a separate soak pit is provided besides confirming to the rules in force.
- 25. No commercial activities will be permitted in the shops unless a separate permission is obtained from this Panchayat.
- 26. All Temporary sheds/Existing building shown to be demolished in the plan are demolished before applying for Occupancy Certificate.
- 27. Fire Escape Staircases, if applicable shall be constructed as indicated in the approved plans.
- 28. All internal courtyards should be provided with drainage outlet.
- 29. The applicant should maintain all existing nature drains in the plot and should not block them at any stage.
- 30. No soak pit or other structures should come in the road widening area.
- 31. The plot boundary should be cordoned off by continuous sheet fencing either of wood or metal during the construction period.
- 32. The Construction or Compound Wall should not obstruct any pathway or public access. The applicant shall make necessary arrangements for smooth flow of rain water by keeping adequate openings in the compound wall for the purpose.
- 33. No gates shall open outwards on the road.
- 34. The Construction of the compound wall should be as per the approved plan. The applicant shall inform this Panchayat after the completion of the compound wall.
- 35. Drinking Water well should be 15 meters away from any Soak Pit.
- 36. Applicant shall dispose the construction debris at his/her own level and/or the same shall be taken to the designated site as per the disposal plan given by the Applicant in the Affidavit at his own
- 37. Applicant shall produce the Certificate issued by the concerned PWD officials of designated sites as mentioned in the said Notification dated 07/03/2018.
- 38. Failing to comply clause (a) and (b) the penalty shall be imposed to the Applicant at the rate of 0.5%on the total cost of the project and also the Construction License issued to the Applicant shall be withdrawn/cancelled.
