

APPOINTMENT OF ADJUDICATING OFFICER

The Goa Real Estate Regulatory Authority established under The Real Estate (Regulation and Development) Act, 2016, invites applications for appointing Adjudicating Officer in the Authority. Section 71 of the Act provides that the Authority shall appoint, in consultation with the State Government, an Adjudicating Officer for adjudging the compensation to be paid to an allottee for various violations by a promoter. The terms & conditions applicable to the posts are as follows:

- Applicant should have served as District Judge.
- Applicant should not have crossed age of 65 years on the date of this advertisement.
- The selected candidate would be paid Rs. 25,000/- per case adjudicated, Rs. 20,000/- per case amicably settled and conveyance for attending work as per approved rates.
- The Appointment would be on contractual basis for an initial period of 2 years, and can be extended for a total period of 5 years.
- The Adjudicating Officer would have to attend office of the Authority, and endeavor to decide applications as per provision under the Act and Rules. The Authority would provide necessary support to the Adjudicating Officer.
